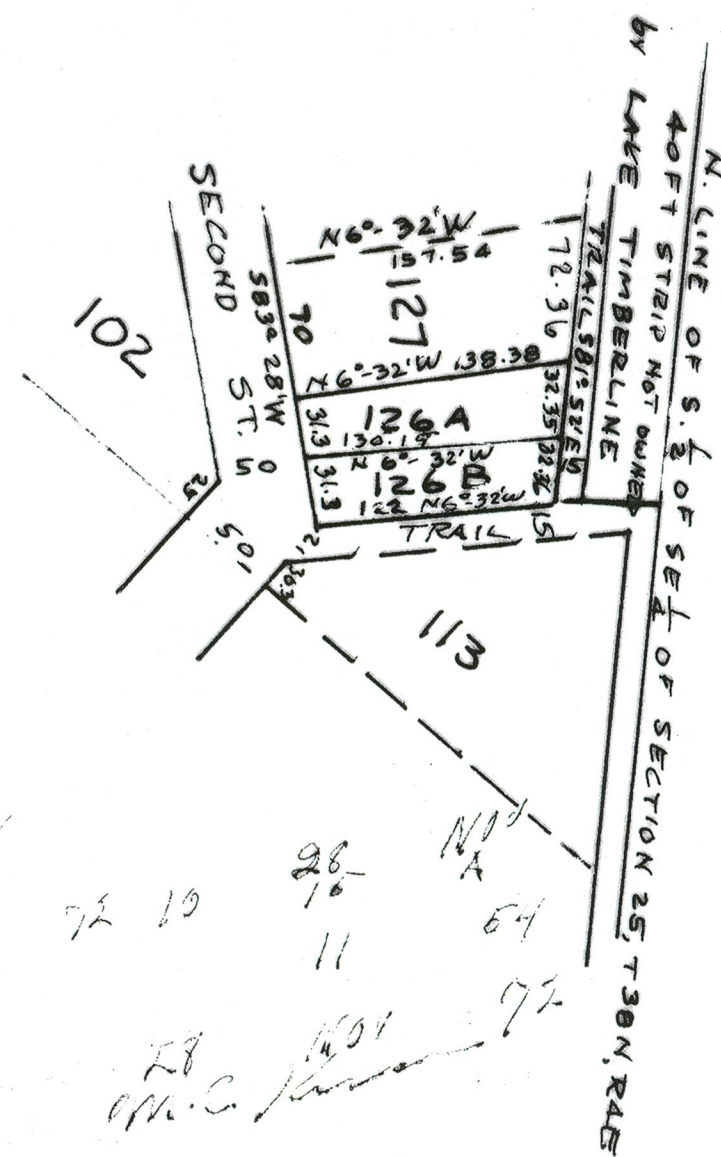


LAKE TIMBERLINE SUBDIVISION
