Stear & Robbins said they would both put some time into this matter. Stear said is would be late Oct. or Nov. before he would have time to check up on them.

Discussion of alternative gate system. Cell Gate is the company. They have been asked to evaluate what we have, offer alternatives and pricing.

Camper fees: Stear showed 1998 covenant article amendment to charge campers staying on property more than 30 days a \$25 fee. This needs to be enforced. Covenant committee may need to refine the amendment. We should be charging per this amendment. We should probably have a sticker just like we have for any other titled property.
