Successors of the Trustees whose term is expiring shall be elected by the lot owners at the Annual Meeting each year and the owner or owners of each lot shall be entitled to one (1) vote for each lot owned having assessments paid in full, which vote may be in person or by absentee ballot or proxy. Only one (1) owner per lot will be allowed to run for a position on the Board of Trustees, or be elected to such a position or serve on the Board of Trustees at a given time. No lot owner will be allowed to run for a position on the Board of Trustees or be elected to such a position unless said lot owner has paid up all assessments due against all lots held in his name. Further, no person shall be allowed to run for a position or serve on the Board of Trustees if he or she or their spouse or significant

other simultaneously holds the position of an Officer or Director of the Lake Timberline Volunteer Fire Department,

Paddle Club, Hilltop Lodge, Dogwood Chapel, or any other Lake Timberline organization or association which the Board

of Trustees may in its discretion and by duly adopted resolution determine to present a possible or likely conflict of interest

as the result of any individual's simultaneous service upon the Board of Trustees and as Officer or Director of such other

organization or association. Additionally, no person shall be allowed to run for a position or serve on the Board of Trustees

if he or she has been previously removed from the Board of Trustees as prescribed in Article VI, Paragraphs 5 & amp; 6

4) John K - He is disputing his most recent tickets. I did allow him to pay the \$10 fee to get his gate card turned back on and told him we would discuss his tickets at the next board meeting. a) His ticket for pulling a trailer thru the back gate - He says Matt Crabtree was back there and told him that he couldn't pull it thru the gate because there wasn't enough time, so he told Matt there was and Matt told him if you think there is then try it (Could have worded it a bit differently but all the same). He also said that the car that piggy backed in after him on that same ticket was another property owner and came in because the gate was open and they had time, he wasn't letting anyone in behind him. Matt did not approve John to go through the rear gate with a trailer.

b) His ticket for allowing a non property owner to use his gate card to get in - He says that "Tommy H" had stolen a plastic bag of stuff from John and the gate card was in it. He didn't

believed his story on this one, so it makes me give it some thought.
